2011 Elections

Thursday 5th May 2011 is the local election date. There will be seven places to be filled and the persons elected will serve for 4 years. We are looking for people who are interested in their community to summon up the courage to put themselves forward for election to the Parish Council. Yes it does involve standing up and taking responsibility and you will have to justify what you say and do, but if you really want to improve people's lives in the village, being a member of the Parish Council is the best place to do it.

So what does your Parish Council do? It has an overall responsibility for the well-being of the village with its work falling into three main categories:

Representing the local community

Delivering services to meet local needs

Striving to improve the quality of life in the local area

For example, Parish Council provides, maintains or contributes to the following services:

Bus Shelters, Cemetery, Community Pavilion, Festivals and Celebrations, Footpaths and Bridleways, Grants, History Centre, Litter and Dog bins, Playing Field, Planning, Open Spaces, Road Safety, School Crossing Patrol, Street Lighting and more!

The Parish Council works with the District and County authorities, Sussex Police, the Environment Agency and local organisations and businesses to ensure the effective delivery of services to the village. It is the seven elected / co-opted Parish Councillors, helped by the Parish Clerk, who identify local needs and ensure that delivery happens.

Most residents are qualified to stand for election but there are a few rules. You can only stand for election if you are over 18 years old and you are a British, Irish, Commonwealth or European Union citizen, You also need to have a local connection, e.g. have lived or worked or be entered on the electoral register for the Parish. You cannot stand for election if you are bankrupt or have served a prison sentence of three months or more within the last five years. Further details of what you would need to do to stand for election will appear on our village notice boards etc. in due course.



Parish Council Precept

Parish Council, sensitive to the current economic circumstances, has voted to maintain the 2011/12 precept at £26,000 for the fourth consecutive year, which in turn mean's no increase in the Parish Council element of your final Council Tax bill.

Parish Council precept is the annual amount of money claimed from the District Council, and funded by Council Tax, to cover the Parish Council's net costs for the coming year. After careful consideration Parish Council believes it can maintain its services while at the same time not increasing the precept.

The 2011 Census

Your 2011 Census Questionnaire will arrive in March. It's vital that you complete your confidential Census Questionnaire as the statistics are used to make decisions about our community. Our area receives funding from government, based on the number of people living here, funding that can be used for schools, hospitals, transport and refuse collection. Everyday facilities like play parks, water pipes and even where your local supermarket branch is located, are based on census statistics. It's all confidential, so no one will see your personal information.

Reminder to Dog Owners

Please help to keep Catsfield's open spaces and footpaths free from unsightly and unpleasant dog mess, by disposing of it responsibly. The Dogs Act 1996, requires that all dog owners must clean up after their dog if it fouls in a public place, as it is not just an eyesore but also a health hazard.

If you are one of the few owners who refuse to clean up after your dog, you could be issued with an on-the-spot fine of £50 each time an offence occurs. With sufficient evidence against a persistent offender, or those who refuse to pay the on-the-spot fine, the District Council will not hesitate to prosecute. This could lead to a fine of up to £1,000.
